#### **Section 4 - First Aid Measures**

# **Section 5 - Fire Fighting Measures**

#### **LARGE SPILLS:**

In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective clothing including eye/face protection. All skin areas should be covered.
