Section 4 - First Aid Measures

General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

Inhalation: If inhalation of liquid occurs, contact a Poisons Information Centre. Urgent hospital treatment is likely to be needed. Remove source of contamination or move victim to fresh air. Section 7 - Handling and Storage
