# **Section 5 - Fire Fighting Measures**

#### Large Spills:

In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC. #### **Small Spills:**
