Section 4 - First Aid Measures

Section 5 - Fire Fighting Measures

Specific hazards: Flammable liquid and vapour. May form flammable vapour mixtures with air. Flameproof. equipment necessary in area where this chemical is being used. Nearby equipment must be earthed. Electrical requirements for work area should be assessed according to AS3000. Vapour may travel a considerable distance to source of ignition and flash back. Avoid all ignition sources. All
